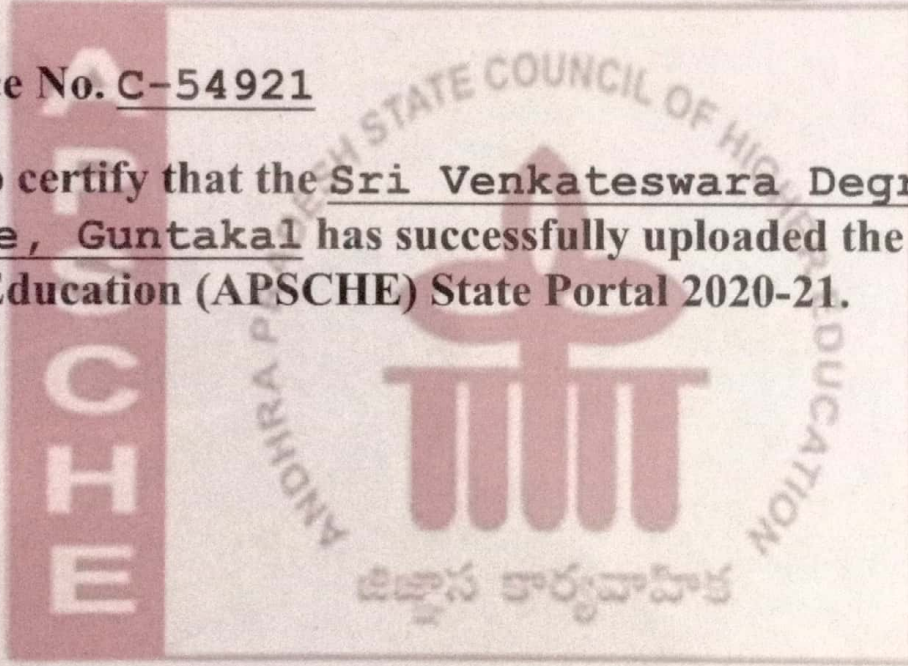

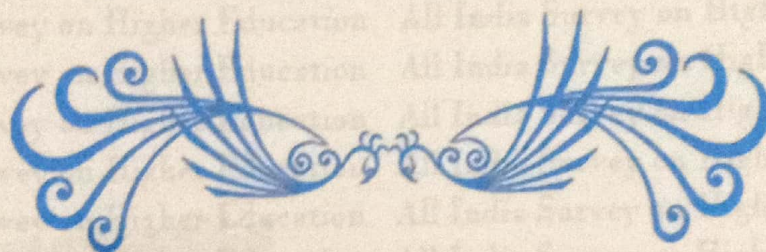



3. AIMS AND OBJECTIVES OF THE SOCIETY:

1. To establish Nursery Schools, Kindergarten Schools, Primary, Upper Primary Schools, Oriented Schools, Junior Colleges, Degree Colleges.
2. To promote Educational Standard like National and international Schools, Residential Schools, Colleges, Secondary Schools, Oriented Schools, Medical Colleges, BDS Colleges, Engineering Colleges, Pharmacy Colleges, Nursing Colleges, Polytechnic Colleges and B.Ed., colleges in rural and urban areas.
3. To establish and organize the Crushes in which the Preprimary School Kids will be looked after.
4. To provide education in various courses by distance education mode.
5. To give comprehensive training in Vocational Training, Fashion Technology Training, Textile marketing management etc., to Rural and Urban area unemployed youths.
6. To help the eligible unemployed youth to get into the Outsourcing Jobs in all Departments of the Government.
7. To establish educational institutions and hostels of Minority Communities.
8. To provide Diploma and PG Diploma course through Correspondence in Education Sector, Business Management, Business Administration, Nursing Management, Materials Management, Export and Import Management, Hotel Management, Catering Management, Banking & Travel & Tourism Management, Financial Management, Labour Laws, Human Resources Development, Production Management, computer in office management, computer application, Hospital Administration, Internet & Networking, Software capability, maturity Model international air lines management, E-Commerce Application, web designing application.
9. To establish Village Libraries in the rural village areas and also develop the community hall in that village through our society and also conduct blood donation camps and also establish a community hall in that village.

10. To take the management of Mid Day Meals Programme at Government Schools.
11. To establish All competitive coaching Institutions to the rural and urban area unemployed youth through our Society.
12. To encourage sports and games in rural and urban youths.
13. To promote cultural initiatives in order to raise the Social Consciousness of the poor and to bring-out the hidden power in them removing this attitude of subjugation and culture of science.
14. To establish Nursing Homes, Blood Bank Centers, Health Services to the Rural and Urban people (Medical Care, mother and child care) Family Planning Services, Health Education, Prevention Diseases control other rehabilitation services and family counseling.
15. To promote agricultural development like support to small formers, to conduct cultural and academic programs, sports, martial arts and games, tournaments, competitions and seminars, workshops, exhibitions and conferences in Andhra Pradesh as well as in India and abroad.
16. Help to the Handicapped persons, Disabled persons and Mental Retardation persons in rural and urban areas.
17. To provide Career guidance and career counseling to rural students and taking active role in career development activities.
18. To establish Urban Health Centre and Health Centers to the Need people in Rural and urban areas.
19. To establish Old Age homes, Orphanage Homes in rural and urban areas for the benefit of the rural and urban area people, free food and accommodation to the Old age persons and Orphanage children in that home through our Society.
20. To establish all competitive examination coaching centers and also provide all job Consultancy, Educational consultancy to the rural and urban area unemployed students.

7. The Membership of the Society shall consist of persons who are signatories of the Memorandum of Society.
  8. Every Member of the Society shall be bound by the provision of the Memorandum of Association of the Society and the rules and regulations of the Society by laws and decision made time to time by the Society in general body meeting of by the Governing Body.
  9. Admission to the Membership and membership amount shall be at the absolute discretion of the Governing Body.
    - a) Automatically at the death of the person.
    - b) Voluntary of termination of the membership.
    - c) Involuntary by resignation of the membership governing body by the resolution duly passed by a majority of vote's body of the society.
2. Admission of Membership : The person after qualifying for the membership shall be admitted into the ambit of the society by a resolution passed by the committee. In case of internal dispute, a 3/5<sup>th</sup> majority of the 'committee' is required for admission.

#### 5. MANAGEMENT OF THE SOCIETY :

The Management of the Society shall be entrusted in the Governing Body of the Society

#### 6. POWERS OF GOVERNING BODY: (Consists of 07 Members)

The Governing Body shall have full powers over the functioning of the society and its funds and properties and for appointment and discharge etc., of the necessary staff and advisers etc., if any one of the office bearers don't attend the meeting for 2 meetings continuously his designation and automatically terminated office bearership and membership lost.

The Governing Body shall have the power of elect any of the member of the Governing Body when there is a vacancy.

#### 7. Cessation of Membership :

A member shall lose his / her membership on the following grounds and reasons and the Committee is empowered to take such decisions :

- On his / her death.
- On his / her absence without permission of the President in two consecutive meetings.
- On his / her resigning from the membership of the society.
- He / she who becomes of unsound mind.
- He / she who is hindrance to the achievements of the aims and objectives of the society.
- He / she who has been declared insolvent.
- Convicted of an offence involving moral turpitude or sentenced by a criminal court to a fine of not less than rupees one thousand or to imprisonment for a period of not less than six months.

- He / she does not subscribe his membership fee, beyond three months of the due date.
- Disqualified for such an appointment by an order of a Court.

#### 8. TERMINATION OF MEMBERSHIP :

A person who ceases to be a 'member' of the society can approach the 'committee' for review of the decision. In case of internal disputes, a 3/5<sup>th</sup> majority of the 'committee' is required for termination of membership. The decision of the 'committee' regarding the termination shall be communicated to the member concerned.

#### 9. GOVERNING COUNCIL:

There will be a Governing Council composed of the Office Bearers of the Society namely the President, Vice President, Secretary, Joint Secretary, Treasurer and Two E.C. Members - Total - 07 Members. All are elected by the Governing Council.

#### 10. MEETING OF THE GOVERNING BODY:

The Governing Body shall meet once in January, March, May, July, September, and November months at such times and places as the President / Secretary from time to time to determine.

#### 11. GENERAL BODY : Powers and functions of the General Body

- 1) It will consider the annual statement of accounts of the society.
- 2) It decides on the General policy of the society and considers such objects as may be placed by the Governing body.
- 3) It appoints the auditors to audit the accounts of the society.
- 4) If affects the office bearers of the society.

#### 12. FUNCTIONS AND DUTIES OF THE OFFICE BEARERS :

##### (1) POWERS AND DUTIES OF PRESIDENT

- i. President shall preside over all the meetings of the society.
- ii. President shall have the power to allow inclusion of any subject / matter in agenda for the discussion in the course of proceeding / meeting.
- iii. President will sign all the papers / letters, on behalf of the society, to conduct its correspondences.
- iv. The president shall have the power to act on behalf of all conveyances, mortgages, leases or and all other deeds and documents that are required to be executed by and on behalf of the Association, provided all the resolutions to that effect are passed by a 3/5<sup>th</sup> majority of the 'executive committee'. All such acts of the president shall be effected and binding on the Association as if executed by the Association itself.

- v. At the time of voting on any matter / subject (except election), if the total votes of the groups of members happen to be equal in number, the president has the power to cast an extra vote to decide the matter / subject.
- vi. Shall have power to call a General Body meeting / Executive Body meeting.

**(2) POWERS AND DUTIES OF VICE PRESIDENT :**

- i. The Vice President of the society shall enjoy all the powers of the President in his / her absence.

**(3) POWERS AND DUTIES OF SECRETARY :**

- i. To call meetings of the General Body / Executive committee with the consent of the President.
- ii. To keep minutes of all meetings of General body / executive committee.
- iii. To keep and preserve the records of the Society. Shall be legally responsible for all record keeping.
- iv. Shall be overall in-charge of the administration and execution of all the programmes of the society, in the furtherance of the objectives of the society.
- v. He shall conduct correspondence on behalf of the society.

**(4) POWERS AND DUTIES OF JOINT SECRETARY :**

- i. In the absence of the secretary, on the direction of the President, he / she shall look after the works of the Secretary and do any other work as authorized by the President.

**(5) POWERS AND DUTIES OF TREASURER:**

- i. The treasurer shall collect the subscriptions from the members.
- ii. Shall keep accounts of all financial transactions of the society and of all the amounts received and spent by the society,
- iii. Shall maintain records of receipts and expenses.
- iv. Shall maintain records of assets, credits and liabilities.

- vi. Shall get the accounts audited by the chartered accountant appointed by the Executive committee at the closure of accounting year, every year.
- vii. Financial year of the Society shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of the succeeding year.
- viii. Shall submit to the General Body Meeting, the annual accounts and budgets of the society.

(6) POWERS AND DUTIES OF EXECUTIVE COMMITTEE MEMBERS :

- i. Shall attend all meetings regularly.
  - ii. Shall participate in all activities of the society, for the furtherance of the aims and objectives of the society.
13. Records to be kept by the Society : The registers may be kept at the registered office of the society and be open during business hours to the inspection of any members or creditors of the society without payment of any fee there for and with a prior notice to the President / Secretary.
- i. Records to be maintained by the Secretary :
    - Copy of the "The Andhra Pradesh Societies Registration Act, 2001.
    - Copy of the registered memorandum along with up-to-date bye-laws with amendments made from time to time.
    - Minutes book.

    - Project reports submitted by the respective Sub-committee conveners.
    - Register of Mortgages and charges.
  - ii. Records to be maintained by the Treasurer :
    - Accounts of all sums of money received and expended by the society and their respective purposes
    - Accounts of all purchases and sales of goods by the society.
    - Accounts of all assets and liabilities of the society.
    - Copies of audit reports and compliance reports thereof.
    - Cash Book, Day Book, Ledger, Vouchers and Bills.
14. Change and Amendments in the Rules and Bye Laws :  
Any change or amendment in the rules and bye laws may be done by the executive committee called for this purpose and approved by more than 3/5<sup>th</sup> of total strength of the committee. The amendments shall be confirmed by 3/5<sup>th</sup> of the members present at a general body meeting convened for the purpose, within a period of one month of the first meeting. This information along with attested copy of Rules and Bye laws should be sent within a week, to Registrar of Societies for incorporation / confirmation.
15. FUNDS AND BANK ACCOUNT : The funds will be spend only for the attainment of the objects of the society and no portion there of shall be paid or transferred directly by the office member through and means. Bank account joint name and joint operation President and Secretary or Treasurer.

16. Renewal of Registration of Society : Once in every year a list of the office bearers and executive committee shall be filed in the office of the Registrar of Societies, Kurnool District, as it is required under the provisions of The Andhra Pradesh Societies Registration Act 35 of 2001.
17. Filling of Vacancies : Vacancies in the executive committee due to resignations or otherwise shall be filled up on ad-hoc basis, by a majority vote in the executive committee. Such a filling of vacancy should necessarily be confirmed by the General Body meeting, convened within a period of three months.
18. Supply of copies of the bye laws : A copy of the bye laws shall be provided to each member of the society at the time of admission.
19. Supply of copies of balance sheet : A copy of the balance sheet or a statement of accounts together with the auditors report shall be supplied to every member of the society at annual general body meeting, if not supplied in advance.
20. Society to be a body corporate : The registration of the society shall render it a body corporate by the name under which it is registered having perpetual succession and a common seal. The society shall be entitled to acquire, hold and dispose of property, to enter into contracts, to institute and defend suits and other legal proceedings and to do all other things necessary for the furtherance of the aim for which it was constituted.
21. Legal Proceedings :
- a) The executive committee or any member of the executive committee authorized in this behalf by its byelaws, may bring or defend any action or other legal proceedings touching or concerning any property or any right or claim of the society and may sue and to be sued in the name of the society.
  - b) Any action or legal proceeding shall not abate or be discontinued by the death, resignation or removal from office of any member of the society after the commencement of the proceeding.
22. Amalgamation and division of Society :
- a) Any two or more societies may, by a special resolution of both or all such societies, and confirmed by a like resolution at a second meeting of both or all such societies, convened after an interval of one month after the first meeting, get amalgamated into one society with or without any dissolution or division of the funds of any of the societies with intimation to the registrar.
  - b) The society by a special resolution divide itself into two or more societies. Such resolution shall contain proposals for the division of the assets and liabilities of the society among the new societies into which it is proposed to divide itself and may specify the area of operation of and the members, who will constitute each of the new societies.

- c) An amalgamation or division in pursuance of this bye law shall not prejudice any right of a creditor of any society which was a party to such amalgamation or division.
23. Dispute regarding management : In the event of any dispute arising among the Committee or the members of the society, in respect of any matter relating to the affairs of the society, and member of the society may proceed with the dispute under the provisions of the Arbitration and Conciliation Act, 1996 (Central Act 26 of 1996) or may file an application in the District Court concerned and the said Court shall after necessary inquiry pass such order as it may deem fit.
24. Dissolution of Society and adjustment of its affairs :
- a) The society may, by passing a special resolution, determine that it shall be dissolved of and there upon, with prior intimation to the Registrar, it shall be dissolved at the time specified in the resolution and all the necessary steps shall be taken for the disposal and settlement of the property of the society, and its claims and liabilities according to the bye-laws, if any of the society, and if there are no bye-laws to this effect in the manner as the General Body may find it expedient :
- Provided that in the event of any dispute arising among the members of the committee or the members of the society, the adjustment of its affairs shall be referred to the Court and the Court shall make such order in the matter including appointment of liquidator as it deems fit :
- Provided further that if the Central Government or any State Government is a member of, or a contributory to any society registered under this Act, such society shall not be dissolved without the consent of the Government concerned.
- b) The society dissolved under this section shall file with the Registrar a full report showing as to how the property has been disposed off.
25. Property of dissolved Society : If upon the dissolution of any society, there remains, after the satisfaction of all its debts and liabilities, any property, the same shall not be delivered to or distributed among the members of the society, or any of them, but shall be delivered to or distributed among the members of the society or any of them, but shall be delivered to some other society, with a similar objective to be named by a special resolution, or in default thereof, by the Court :
- Provided that this section shall not apply to the society, if the said property is acquired and established by contribution of shareholders in the nature of a Company.

27. Enforcement of Orders:  
Orders made, on application, be enforced as follows :
- a) When made by a liquidator, by any civil court having local jurisdiction in the same manner as a decree of such Court; and
  - b) When made by the Court on appeal, in the same manner as a decree of that Court.
28. Society financed by the Government :  
When the Government has financed wholly or substantially for the projects of the society, the terms and conditions laid down in the mutual agreement shall be respected by the successive executive committees.
29. General :  
All other provisions of The Andhra Pradesh Societies Registration Act 35 of 2001, not specifically mentioned herein, shall also apply to this Society.
